Additional information to consider:

- **If your school purchased a School Fight Song or Band Chant through a music royalties vendor** (such as CheerSounds or Unleash the Beats), it needs to be paid for with a SCHOOL credit card to show school ownership. The music must also be listed in the SCHOOL'S name, NOT the coach's name. This is for the school's protection.
- ****iTunes** - This music must be purchased with a school credit card and added to the school account (not the coach's personal account) The music must be a single song; it cannot be cut, edited, or rearranged in any way. The music may be stopped and started again, but parts cannot be modified or taken out.
- **+BAND CHANT provided by school**
 - If someone at your school wrote the Band Chant (original piece), the ICCA will need a letter printed on official school letterhead stating the composer's name and that they have given permission for the cheerleaders to use the band chant for a performance. This must be signed by the composer AND the school principal on school letterhead. It will correspond with Rights/Licensing to use the Music (artist and composer)
- All sound effects added to or used in the Band Chant have been paid for through royalty rights given to the school for use in the routine.
